- 6. N85VM landed Shannon 06/09/2004, Washington/Paphos, Cyprus, technical/fuel stop
- 7. N85VM landed Shannon 09/09/2004, Palma/Washington, technical/fuel stop
- 8. N227SV landed Shannon 02/10/2004, Ruzne/Washington, technical/fuel stop

I do not have records relating to any of the other flights. Where I found details of passenger numbers I have listed them. It should be noted that in accordance with the 1944 Chicago Convention on International Civil Aviation, aircraft may come into Ireland for technical stops such as for refueling purposes, without the requirement of obtaining traffic rights from or notifying this Department. The filing of flight plans and air traffic control are matters for the Irish Aviation Authority, and the issuing of slots to aircraft landing at particular airports a matter for airport authorities. It should be noted that neither the Irish Aviation Authority nor the 3 State airports, Dublin, Shannon or Cork, come within the remit of FOI legislation. A note on FOI Review Procedures is attached.

There is no fee for a review of personal information.

A review of a decision on foot of formal 3rd party consultations should be appealed directly to the Office of the Information Commissioner.

## THE INFORMATION COMMISSIONER

When an internal review has been carried out and the requester is still not satisfied with the outcome, the requester may then appeal to the Information Commissioner.

The Office of the Information Commissioner was established under Section 33 of the Freedom of Information Act 1997. It is an independent office and has powers to review certain decisions made by public bodies.
